Subject: For providing Electronic Voting Machine (EVMs) for the election of the District
Bar Association, Gurugram, reg.

Sir,

I have been directed to refer to your letter No. 1668, dated 14.12.2021 on the above subject and to say that 40 EVMs for Bar Association election to be held on 17.12.2021 may be used from the 70 EVMs recently supplied to your district for ensuing general election of Municipal Council, Sohna, on the following terms and conditions:-

Terms and conditions

- (i) Hire charges for EVMs (one CU & and one BU) shall be Rs. 100/- per day and in case of loss or damage an amount of Rs. 10,000/- per EVM shall be charged.
- (ii) Price of the power pack (battery) shall be charged @ Rs. 200/- per power pack and the same shall be deposited in the receipt head of the State Election Commission i.e. 0070-Other Administrative Services-02-Election-800 Other Receipts-98-Other Receipts of state Election Commission.
- (iii) The EVMs shall be handled only by the Government officials and shall not be handled by any private persons in any circumstances.
- (iv) All expenses regarding transportation (to and fro) loading, Unloading, taxes etc. including the cost of repair/replacement along with TAVDA of staff shall be borne by in borrowing authority.
- (v) The supplied EVMs shall be returned to the concerned authority i.e. Deputy Commissioner-cum-District Election Officer (P) and handed over to the officer concerned handling the EVMs for municipal election, immediately after the completion of elections under intimation to the Commission. Further these EVMs shall be returned to Municipal Council, Sohna, Gurugram.
- (vi) The Govt. official deployed for election shall be paid proper remuneration etc. by the Bar Association, concerned.
- (vii) Proper protocol is ensured while transporting and use of these EVMs.
- (viii) Power packs (batteries) if not available in the district may be collected from the Commission.
